

**Information on the processing of personal data
for persons entering the premises via vehicles in the
Syntom Metal Recycling Sp. z o.o.**

<p>Who is the controller of personal data?</p>	<p>Pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (hereinafter: GDPR), we inform you that the controller of your personal data is Syntom Metal Recycling Sp. z o.o. with its registered office in Warsaw (02-672) at Domaniewska 17/19/133 Street (hereinafter: Controller).</p> <p>The Controller can be contacted via:</p> <ol style="list-style-type: none"> 1. by regular mail (by sending correspondence to the Controller's registered office address indicated above) 2. email address: biuro@syntom.pl. <p>The Controller is responsible for the security of the personal data provided and the processing of the data in accordance with the law.</p>
<p>For what purpose and on what legal basis do we process personal data?</p>	<p>Your personal data may be used by the Controller for the following purposes:</p> <ol style="list-style-type: none"> 1. to ensure the safety of employees and co-workers, to protect property and to maintain the secrecy of information, the disclosure of which could expose the Controller to harm (legal basis: Article 6(1)(f) GDPR - legitimate interest), 2. ensure the safety of individuals on the Controller's premises (legal basis: Article 6(1)(f) GDPR - legitimate interest), 3. to assert or defend against possible claims, related to entry the Controller's premises, or in connection with the need to prove certain facts that are material to the Controller in this regard (legal basis: Article 6(1)(f) GDPR - legitimate interest). <p>Entering the Controller's premises entails the obligation to provide personal data, including the data of your vehicle, such as the registration number.</p>
<p>How long will we use the acquired data?</p>	<p>Personal data will be used for the period necessary for the purposes indicated above. Depending on the legal basis, this will be respectively:</p> <ol style="list-style-type: none"> 1. the period of possession of the right to enter the Controller's premises, 2. the period until the final conclusion of the proceedings, if your data will constitute evidence in a proceeding under the law or the Controller became aware that they may constitute evidence in the proceeding, 3. period until any effective objection is filed.
